Problem rationale




Figure 1: Disruptions in supply chain causes disruptions in integration of supply chain (Source: [7], 2021)

FINDINGS AND DISCUSSION




Figure 3: Connection between supply chain integration and others (Source: Influenced by [10]. 2018)




Figure 4: Effect of practices of environmental management (Source: Influenced by [10]. 2018)
