# Theme 3: Issues in infrastructure as an emerging problem in online education



educational systems. Research has projected that 52% of US graduate students have a better learning experience through the online learning process than their regular-based classroom education [17].




**Figure 1:** learning experiences of college students: online vs classroom [17]
