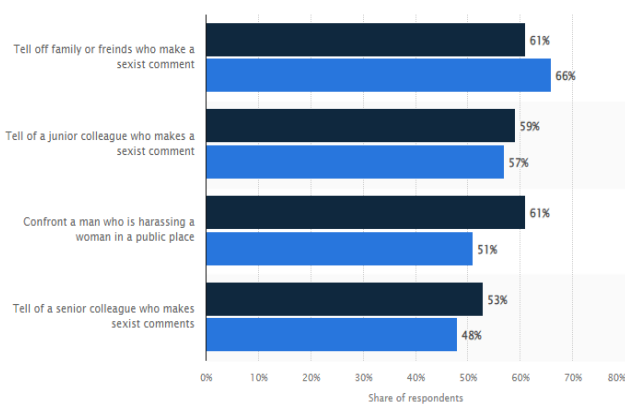


Figure 1: Confidence of handling sexism
